Hundreds of investors worldwide approached the firm for assistance once the truth about Madoff's scheme hit the news. The firm's extensive efforts, including successfully petitioning for Madoff's declaration of involuntary bankruptcy, despite objections from federal agencies, have so far benefited almost all the victims.
